The Canvass Meeting was called to order at 7:00 pm by Mayor Royce Erdmann. Present council members: Jackie Leibel, Jackie Rau, Michael Yost, and Alan Wimer; Richard Reis was present via speaker. City personnel present: Sondra Waltman. Brett Schaible joined the meeting at 7:03 pm.

Wimer moved with a second from Rau to pay the predetermined election expenses. All in favor, motion carried. The meals totaled \$67.10 and will be split with the Leola School. The election expenses are as follows:
